NOTICE

There is a state of emergency in Ohio due to the prevalence of COVID-19. Pursuant to Ohio Revised Code 3701.13, the Ohio Director of Health has issued several public health orders. If a facility cannot comply with these orders they are to shut down.

This facility is currently in violation of one or more public health orders. Violation of an order is a criminal offense under Ohio Revised Code (ORC) 3701.99 and a civil offense.

At time of inspection this facility was **NOT** in violation of one or more public health orders.

APPLICABLE PUBLIC HEALTH ORDER

- 3/14/20 Order to Require Health Screening for Admission to State Operated Psychiatric Hospitals or to Department of Youth Services Facilities.
- 03/14/20 Order the Closure of All K-12 School in the State of Ohio. (3/17/20 - 4/3/20)
- 03/15/20 Health Director Order Limit Access Jails and Detention Facilities.
- 03/15/20 Health Director Order Limit Food, Alcohol Sales to Carry Out Delivery Only. (No onsite consumption is permitted. Social distancing required. Some exemptions apply.)
- 03/17/20 Order to Limit and/or Prohibit Mass Gatherings in the State of Ohio (Amended). (Closure of bowling alleys, health clubs, gyms, yoga studios, indoor trampoline parks, indoor water parks, movie theaters and performance theaters, public recreation centers, indoor sports facilities, etc.)
- 3/20/20 Director's Order to Cease Business Operation at Hair Salons, Day Spas, Nail Salons, Barber Shops, Tattoo Parlors, Body Piercing Locations, Tanning Facilities and Massage Therapy Locations.
- 3/21/20 Order to Close Facilities Providing Older Adult Day Care Services and Senior Centers (effective COB 3/23/20)
- 3/21/20 Order to Prohibit Adult Day Support or Vocational Habilitation Services in a Congregate Setting (effective 9pm 3/24/20)
- 3/21/20 Order to Cease Business Operations and Close Venues (indoor family entertainment businesses and venues, dance studios, arcades, indoor mini golf, ice/roller skating rinks, laser tag, etc.)
- 03/22/20 Order that All Persons Stay at Home Unless Engaged in Essential Work or Activity.

- In addition to the above, the continued operation of this facility in violation of the above is a nuisance and a danger to life and public health in violation of ORC 3707.01 and you are hereby being ordered to cease the above identified activity pursuant to ORC 3709.21 and 3707.01. Due to COVID-19, this order is an emergency and is effective immediately.
